Approval of The Scheme of amalgamation

“RESOLVED THAT pursuant to the provisions of Sections 230 to 232 and other applicable provisions, if any, of the Companies Act, 2013, ("Companies Act") read with Companies (Compromises, Arrangements and Amalgamations) Rules, 2016 and other rules made thereunder (including any statutory modification(s) or re-enactment(s) or amendment(s) thereof for the time being in force), Section 2(1B) read with any other applicable provisions of the Income Tax Act, 1961 (as amended) ("IT Act"), and other applicable laws, including regulations issued by Securities and Exchange Board of India ("SEBI"), inter alia including applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations'), the relevant provisions of Memorandum of Association and Articles of Association of the Company and other applicable laws, rules, regulations, bye-laws as the case may be; and subject to requisite approval of the members and/or the creditors, as applicable, of the Company (unless dispensed with by the Hon'ble National Company Law Tribunal having jurisdiction over the relevant companies), and necessary consents, observations, no-objections, permissions and approvals of the statutory or regulatory or governmental authorities and subject to the sanction of the relevant bench/benches of the Hon'ble National Company Law Tribunal(s) ('NCLT/Hon'ble NCLT') before whom the confirmation petition would be filed, and subject to all such conditions and modifications as may be prescribed or imposed by any of the aforesaid authorities while granting such approvals, observations, no-objections, permissions and sanctions, which may be agreed to by the Company, the consent of the Board of Directors of the Company ('Board), be and is hereby accorded to the draft scheme of amalgamation of Fibcorp Polyweave Private Limited, a Subsidiary of the Company ('Transferor Company') into and with the Company ('Transferee Company', or 'Company'), (hereinafter referred to as 'the Scheme') (a draft of which was tabled at this meeting and was duly initialled by the Company Secretary/ Chairperson of the meeting for the purpose of identification), as per which, effective from opening of business hours on April 1st, 2023 or such other date as the Hon'ble NCLT may direct/ allow ('Appointed Date'), the following shall take effect:

- a) amalgamation of the Transferor Company into and with the Transferee Company in accordance with Section 2(1B) and other provisions of the IT Act, Sections 230 to 232 of the Companies Act and other applicable laws.
- b) the entire Undertaking (as defined in the Scheme) of the Transferor Company shall stand transferred to and vested in and/or be deemed to have been and stand transferred to and vested in the Company to become undertaking of the Company, in the manner provided for in the Scheme.

- c) the value of investment in the Shares of the Transferor Company, appearing in the books of account of the Transferee Company shall stand cancelled, which shall be affected as part of the Scheme and not in accordance with Section 66 of the Companies Act and, in the manner, stipulated in the Scheme.
- d) transfer of the Authorized Share Capital of the Transferor Company to the Company and consequential increase in the Authorized Share Capital of the Company as provided in Part I of the Scheme.
- e) the Transferor Company shall stand dissolved without being wound up.

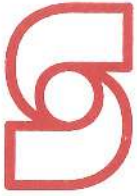

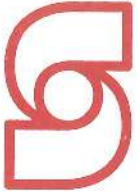
